

These agreements will remain in effect until 2/28/25, and renew automatically for one-year terms unless written notice is provided prior to the start of the next term or upon approval of the Board. No initial sales charge applies on investments of \$250,000 or more (and certain other qualified purchases). However, a contingent deferred sales charge of 0.50% may be imposed on certain redemptions made within 12 months of the date of purchase on shares that were purchased without an initial sales charge.

MainStay MacKay High Yield Municipal Bond Fund: Total annual fund operating expenses for Class I shares: 0.62%. MainStay MacKay Short Term Municipal Fund: Total annual fund operating expenses for Class I shares: 0.44% (Net: 0.40%). MainStay MacKay Tax Free Bond Fund: Total annual fund operating expenses for Class I shares: 0.49%. Class I shares are generally available only to corporate and institutional investors.

*Ratings apply to the underlying portfolio of debt securities held by the Fund and are rated by an independent rating agency, such as Standard and Poor's, Moody's, and/ or Fitch. If ratings are provided by the rating agencies, but differ, the higher rating will be utilized for MTBIX and MSTIX while lower rating will be utilized for MMHIX.
