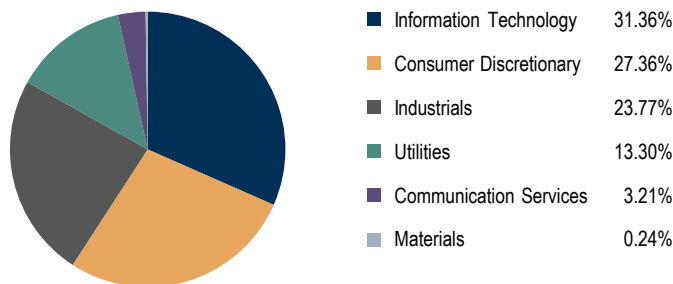

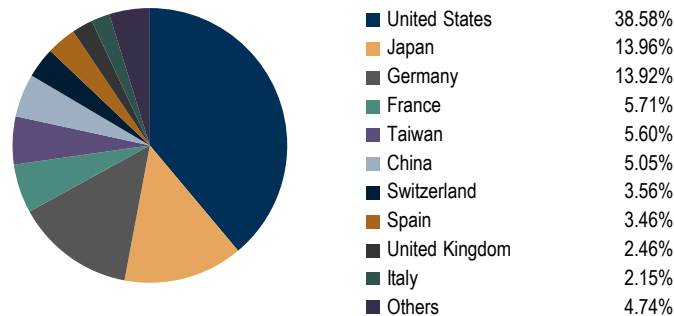


NYLI Cleaner Transport ETF

Before You Invest

Before considering an investment in the Fund, you should understand that you could lose money.
