
# Trading Under Trump





# With Trump's second term underway, all eyes are on the markets. Which sectors thrived last time, and which struggled? Past trends may hint at what's ahead.




# U.S. Equities

With his protectionist stance, U.S. equities generally performed well throughout Trump's first term. However, there were large discrepancies among the indexes.





International equities, though strong overall, tended to show weaker performance throughout the January 2017 to 2021 period.


#### **International Equities**

International equity performance varied during this period, though Europe, Emerging Markets, and China all lagged behind the S&P 500.




